# 1. THE HISTORY OF SHOOTING SPORT IN FISU

The story of Shooting Sport in FISU started in Pilsen, Czech Republic in 2003, where the first edition of the competition was staged. University Shooting Sport events have been successful ever since the beginning as they have been very well organised, with high participation level and shooting results. The key of this success is a very good cooperation with the ISSF, the international governing body for this sport, the National University Shooting Team managers and the popularity of Shooting Sport within students.

During the first edition, the Slovakian shooters led with a total of 14 medals, of which 6 were gold, 4 silver and 4 bronze. They were followed by the Korean delegation with the same number of medals. After a few adverse attempts to organise the second edition of the World University Shooting Sport Championship, finally the Organising Committee of the Summer Universiade in Bangkok, in 2007 included Shooting Sport into the programme of the games. That was a great success in terms of participation as 426 athletes from 40 countries in total took part in these competitions. The high level of the athletes and excellent results assured the future of Shooting Sport in FISU. From 2008 with the second edition of the Championship Shooting Sport in Beijing, China, the Championship was held every two years without any interruption ever since.

After the successful edition of the 2010 World University Shooting Sport Championship held in Wroclaw, Poland, Shooting Sport was appointed as an optional sport for the 26<sup>th</sup> Universiade 2011 in Shenzhen, China. There the record of participation was broken again with 433 shooters from 45 countries. A great participation and a very high level of results were also recognised at the 27<sup>th</sup> Universiade in Kazan in 2013, where Shooting Sport was for the fourth time in the FISU history an optional sport of the Summer Universiade.

The 5<sup>th</sup> Championship Shooting Sport was held in Al Ain, United Arab Emirates, the first FISU event to take place in this country and in the Gulf region. In 2016 the FISU World University Shooting Sport Championship took place in Bydgoszcz, Poland and the 2018 Championship was held in Kuala Lumpur, Malaysia. The 2020 Championship Shooting Sport was supposed to take place in Pilsen, Czech Republic but has unfortunately been cancelled due to the Covid-19 pandemic.

The next edition will take place in New Delhi, India in 2024.

## 4. SPORT REGULATIONS (TECHNICAL REGULATIONS)

### 4.1. GENERAL TERMS

The Shooting Sport event shall be organised in accordance with the most recent technical rules of the International Shooting Sport Federation (ISSF) unless otherwise stated by FISU. In the event of a disagreement in the interpretation of these rules, the English text shall be regarded as authoritative.

The programme and duration of competitions are fixed by FISU in agreement with the Organising Committee and the ITC Championship. The competitions shall last minimum five days and include the following events:

Each country may enter a maximum of 39 persons: 33 competitors and 6 officials.

### Individual Events

#### Rifle discipline

Events for Men, Women: A maximum of five competitors per discipline but no more than three competitors in each particular event.

#### Pistol discipline

Events for Men: A maximum of six competitors per discipline but no more than three competitors per discipline in each particular event;

Events for Women: A maximum of five competitors but no more than three competitors per discipline in each particular event.

#### Shotgun discipline

Events for Men: A maximum of six competitors per discipline but no more than three competitors in each particular event;

Events for Women: A maximum of six competitors per discipline but no more than three competitors in each particular event.

### Team Events

Three competitors per team and country in each particular event.

2 competitor(1-M, 1-F) per team and 2 team per Country.

At the first General Technical Meeting, the Head of Delegation or his/her representative shall confirm and sign the official list of competitors accredited by the CIC.

The team composition shall be confirmed at the General Technical Meeting or at the latest 48 hours before the discipline starts.

## 4.2. PRE-COMPETITION PROCEDURE

Three (3) months before the Championship, the Organising Committee has the right to collect 50% of the total cost of stay per athlete and official from participating countries.

### Format of competition

**Qualification rounds:** The events shall be completed in individual as well as team. In the 50m events, if entries exceed the expected number, elimination rounds shall be conducted.

**Final rounds:** All the Olympic events shall be conducted as finals. The eight highest-scoring shooters in the qualification rounds of rifle and pistol individual events shall qualify for the finals. For the Rapid Fire Pistol men's event and the shotgun event, the six highest-scoring shooters shall qualify for the final.

The non-Olympic events shall be conducted without the final rounds.

Team events shall be ranked from the results list of the preliminary rounds / elimination or qualification.

Shooters have to mention in the entry forms in which discipline of the events they will participate: individual event, team event, or both.

## 4.3. TECHNICAL OFFICIALS

### Nomination and costs

The ITOs shall be appointed jointly by the ISSF and FISU. The Organising Committee shall bear their cost of board and lodging in single room (from two days before the opening ceremony to one day after the closing ceremony). Their travel cost and per diem shall be divided among the participants.

Other costs are referenced in the FISU – ISSF partnership agreement.

## 5. SERVICES

The Organising Committee shall inform the participating countries through the bulletins and its website about the possible and potential services and their costs.

Wi-Fi shall be available for all delegations for free. Costs for a laundry services will be provided as soon as possible to assist with budgeting.

### **Technical Officials**

Technical Officials (TO) Services is complex and must not be underestimated. The Sport functional area must set up an efficient team early in advance.

In coordination with other relevant functional areas, the Technical Officials Services team is responsible for:

- NTOs recruitment in coordination with the Competition Manager and NF;
- support services such as visa, invitation letters, flight tickets and accreditation;
- managing and delivering TO clothing / uniforms when requested;
- procuring suitable accommodation for the period required;
- providing daily catering and transportation;
- ensuring that all TOs are properly qualified (in close cooperation with FISU);
- hosting Technical Officials' meetings;
- per diem and allowance payment.

## **6. COMPETITION VENUE**

The Organising Committee shall present during the inspection visit the layout of the competition venue(s). The complete layout must be sent to FISU Championships Department and FISU TCC for approval. This layout should include all competition and training areas as well as the different areas, accesses and services allocated for each client group taking part in the competition or involved in its delivery.

## **7. EQUIPMENT**

Equipment is listed in the FISU Shooting Sport Venue Minimum Requirements.

## **8. TRAINING SESSIONS**

The training sessions schedule should be drawn up by the FISU Technical Committee Chair together with the Organising Committee Competition Manager and provided to the participating teams as early as possible to make the planning as smooth as possible.

## 9. COMPETITION PROGRAMME

The Preliminary competition program shall be approved by the FISU Technical Committee Chair during the inspection visit and published on the website as soon as approved by FISU TCC.

## 10. SPECIFIC MEDICAL AND ANTI DOPING CONTROL REQUIEREMENTS

The venue medical plan shall be presented by the OC and approved by the FISU TCC during the inspection visit.

## 11. SPORT PRESENTATION

Sport presentation is the audio-visual presentation of a sport in each competition venue of a FISU World University Championship.

Sport presentation has become a vital instrument of major sport events and is key to delivering the Championships sports successfully. It aims to attract, educate, and entertain live audiences at the competition sites and elevates the sport experience for all client groups.

Sport presentation comprises elements such as video clips, sounds, announcements, Championship mascots, creation of fan teams, the involvement of cheerleaders and other innovative elements that increase the understanding of the sport and the attractiveness of the competitions.

It is complex and must be carefully planned to the second, as it can have a substantial impact on the operation of broadcasters and venue teams. Therefore, close collaboration and early communication with broadcasting, awarding ceremonies and the ICT is essential.

Sport presentation planning should ground on one common creative theme that fits with the specific the Championship concept. Nonetheless, as every sport has its own unique characteristics, it is important that each sport presentation is tailored to the particular sport while still embracing the main theme.

Due to its complexity, FISU suggests the OC to consult expert advice for assisting the OC in developing their sport presentation strategy in an early stage of the event lifecycle.

Considering the importance of sport for the sport presentation planning, the OC is recommended to place sport presentation under the responsibility of the sport manager of the Organising Committee.
